CRMF April 2021 Update*by Dave Casteel*

Summer is officially here and things are opening up. Despite COVID, your Foundation has been active. We are currently in the process of negotiating mutually beneficial terms and conditions of the WSU-V Col Paul and Ivadell Crosby / MOAA Endowment Gift Use Agreement with the WSU-V foundation.

As you know, we have an established endowment at Clark College that we have been contributing to for years. The corpus of the endowment is around \$86,000 -- the annual earnings of which currently funds all but about \$500 of the three \$1,000 annual scholarships we award.

At WSU-V, the prospective endowment balance financially kick-started by Paul and Ivadell, now stands at approximately \$14,600 due to some matching and growth, but needs another \$10,400 to be fully endowed. WSU-V is offering to grandfather us before they raise the minimum endowment donation level to \$50,000. The draft agreement requires the CRMF to contribute \$2,080 a year over a five-year period starting next year, which we believe is doable with your continued support.

We thank you again for your very generous response to the January dues letter and want you to know how appreciative we are of your support. While you can make a donation at any time, for those of you who are not able to join us in-person at the barbecue, the next formal appeal will be the September mail appeal in conjunction with our post COVID in-person annual September scholarship kick-off barbecue.

We continue to receive quarterly checks from your participation in the Fred Meyer Rewards program and the www.Smile.Amazon program. We very much appreciate these, although not huge, they do help and we know they can grow with your continued use and support. If you need sign up "how to" information, please let me know.

Fisher House is opening back up to guests and by the time you read this, will be at 50% capacity. In the past, through the Support The Troops fund, the CRMF has donated physical items (such as door room number

plates, room alarm clocks and suitcase stands, patio umbrellas and stands, barbecue grill covers, and benches for those waiting for the VA shuttle, just to name a few). We have also donated gifts cards for the staff to use to fund emergency or urgent needs of the guests (such as Uber fares to/from the VA hospital in Portland after the shuttle has stopped running) and food needs when there are not enough volunteer meals prepared. We have contacted them again to inquire about their current needs.

RMDs. You can make Qualified Charitable Distributions (QCDs) directly from your IRA RMD. The benefit to you is that the QCD reduces your AGI on the front of your IRS Form 1040 dollar for dollar, thereby reducing the amount of tax you owe.

Stock transfers. If your portfolio has increased recently, you can tell your financial institution to DTC "xxx" number of shares or "\$xxx" to our Vanguard Brokerage account. The benefit to you is that you will avoid paying capital gains tax on the transfer of securities held long term (which you would have owed if you cashed them in and then donated the resultant cash).

I consider it an honor and a privilege to serve as your foundation president and on behalf of our officers and board of directors, want to thank you for all you do to support our veteran community.

Scholarship Corner By Paul Crosby

The chapter recently renewed its commitment to a WSU scholarship endowment when it agreed to a Gift Use Agreement. What this means is when our Current Use Fund at WSU-Vancouver reaches \$25,000 it becomes an endowment.

The chapter currently has \$14,600 in our Current Use Fund, \$10,400 short of the \$25,000 needed for an endowment for the Colonel Paul S. and Ivadell M. Columbia River MOAA Foundation Scholarship. To reach \$25,000 the Gift Use Agreement commits the chapter to five annual payments of \$2,080 beginning in April/May 2022. We can complete this commitment early if funds allow

The reason I am providing this information is there is a sense of urgency to fulfill this agreement. At WSU-Vancouver there is an expectation that the minimum needed to start an endowment with the WSU Foundation will increase from \$25,000 to \$50,000 sometime later this year. This is the reason the chapter has agreed to the Gift Use Agreement, we want to beat this increase.

Chapter members are probably wondering what they can do to help meet this agreement. Member contributions have sustained our three Clark College endowment scholarships for over 23 years and for our WSU scholarship since 1992. Through member support our Clark College Foundation endowment is almost self-sustaining. This is another opportunity to reach a long-term goal by creating an endowment at WSU. The board asks that you remember this endowment when you are asked to contribute at our annual barbeque in September and at our holiday social in December.

Chapter Travel Forum Update

The Chapter's second *Travel Forum* was held the evening of May 13th as a Zoom meeting. Nine members plus several spouses participated during the hour discussion.

Much of the second Forum continued the discussion about planning trips and traveling during the pandemic. Despite relaxing mask requirements and increasing vaccinations, travel restrictions and constraints mostly remain. The following advice from the first Forum remain applicable even though changes in guidance and rules are rapidly changing:

- Do your research for travel and destinations early before booking to determine testing requirements and timelines; then, frequently check for updates.
- Give yourself plenty of time to obtain the test, set up and do the test, and get the results back before commencing travel
- Airline and cruise websites are a good source of information about COVID-19 tests, and other requirements and restrictions.
- Many hotels and resorts can help arrange tests for the return trip to the U.S.A.—costs vary—but expect a \$100 or more.
- Make sure you have a copy of all test results and other required COVID documentation on your cell phone as well as carrying printouts.

Other items of interest and discussion:

- Rental car prices are going up—significantly in some locations. Rental car companies reduced their fleet sizes. Now, demand is greatly exceeding supply. In several cases cited, prices have at least doubled in some places. Some recent post-forum sources have noted that prices in Europe are likewise ticking up. Costco was recommended as a source for finding the best rates.
- Some travel agents are continuing to report surging interest and reservations for tours and cruises for later this year and 2022. Key factor right now is “when” and “how” the European Union will reopen to tourism from the U.S.
- The following website was added to the recommended list of websites to research future travel: vantagetravel.com.

Federal Legislative Update: ***by Buck Marr***

What season is it??? Baseball? Golf? Tennis? Fishing? Boating? Graduation? No way, it is “Lobby” Season (aka advocacy)! And, I know all of you have mailed the letters in the April MOAA magazine and/or called/emailed your legislators and/or their staffers on the three Advocacy in Action (AIA) campaign issues. **Dave Casteel** is our state advocacy leader. He has tirelessly organized the entire effort for Washington’s ten chapters! He will likely have talked to 11 legislative offices by campaign’s end. Well done!! Individually, we need to follow his lead.

To give you some measure of the magnitude of the campaign, as of 28 May, over 400 MOAA volunteers in every state conducted over 200 meetings with Congressional members and/or their staff members. Over 10,000 letters on the three advocacy topics were sent to congressional offices. Given the delayed submission of the President’s proposed budget, there is still time to send messages on these Advocacy in Action topics. Let’s take a quick look at the President’s FY22 proposed budget submitted on 28 May. It’s important to note that the budget has several elements combined: The American Jobs Plan (\$2.3T), the American Families Plan (\$1.8T) which when added to discretionary and mandatory spending will total close to \$6T. Defense, including Defense Agencies, is a discretionary spending item increased in this proposal by 1.7%. Nondefense spending is proposed at +16%. VA mandatory and discretionary spending is elevated by about 10%.

The \$715B Pentagon budget is advertised at +1.6% but is about +.4% when adjusted for inflation. Some savings will accrue by a total force end strength reduction of around 5300. The proposal includes a 2.7% pay raise for both uniformed military members and civilian defense department personnel with a directive to raise the minimum hourly pay for civilians to \$15/hr. It proposes to add approximately

50,000 full time equivalent federal employees to the books.

A final note, the long standing Overseas Contingency Account (OCA) is canceled in this budget proposal. According to a senior member of the House Armed Services Committee, rolling contingency expenses into the budget baseline will make the defense budget \$38B short. Adding to the debate will be a proposal by another legislative caucus to cut defense spending by 10%. Combining early congressional reaction with a quick peek at a legislative crystal ball hints the road to a defense budget will be filled with acrimony and finger pointing. The MOAA Nation must stay intensely focused on our issues.

Beyond the budget and under the heading of “good news,” MOAA has been pushing the VA to re-adjudicate veterans claims previously denied service connection for a herbicide related condition. The VA reversed their position and announced in April that they would automatically review these claims.

And, in an over the horizon look at new or ongoing issues: MOAA is building a plan to advocate for premium free health and dental care for reserve component members. This is valid given the incredible changes in the nature of their service in recent years.

Next, is the ongoing saga of a military housing tenant bill of rights, MOAA is closely watching to see that the last four, all important, provisions are implemented. The other 14 were implemented in 2020 but the remaining four are the most important tenants. They deal with dispute resolution, rent withhold, leases and transparency of maintenance history. These provisions have been delayed while negotiating with privatized housing companies.

And, finally, MOAA continues to lead the effort to cancel the proposed 18,000 medical billet cuts representing an 18% cut to uniformed medical personnel. Stay tuned.

Federal Legislative Update continued

So, what is the status of the defense-oriented legislation process? Most of the combatant commanders and equivalents have testified to the Defense committees and subcommittees. In theory, these testimonies establish the “requirements” baseline. With the testimonies complete, the committees will continue to meet to form their individual inputs to the NDAA. A key lawmaker said recently that the President’s priority is delivery of The American Plan which is on target for a vote just before the August recess. That will push the defense authorization act to after the recess making a continuing resolution almost a sure thing.

We can’t influence the topline President’s budget but we can continue to follow **Dave Casteel’s** example pressing our legislators to support our veteran community.
