The latest COVID-19 updates show Southwest Washington continues to feel the sting of rising case numbers – with the highest activity rates we’ve seen since January. **Governor Jay Inslee** stated in his September 9 press conference hospitals across Washington are being over-run by COVID admissions and demands for ICU beds. As result he expanded existing mask mandates to require masks at outdoor events of more than 500 people.

Given the average age and health conditions of many of our members, our chapter executive board decided to again discontinue in person membership meetings for the remainder of 2021. We will revisit this decision in January 2022 in hopes the numbers of COVID hospital admissions and deaths drop.

CRMF August 2021**Update by Frank Hill Treasurer**

It's been a busy couple of months for the CRMF, with more on the horizon. But that's good news because it means your donations are being put to work assisting veterans and their families.

Our annual scholarships have been awarded and were paid for last spring. They consisted of three \$1,000 scholarships to Clark College students, and one \$1,500 scholarship to a WSU-Vancouver student.

There is some really great news related to our Scholarship efforts. As you know, initial funding toward the "*Colonel Paul S. and Ivadell M. Crosby Columbia River MOAA Foundation Scholarship Fund*" at WSU began with a generous donation from the **Crosbys** plus a smaller donation from the CRMF. These donations, totaling \$14,600, are being held in a "Current Use Fund" pending CRMF donating the remaining \$10,400 needed to reach the \$25,000 Scholarship Gift Use Agreement (formerly 'Endowment') minimum. Our plans were to make donations over time and as funds were available until the minimum was reached.

As John Steinbeck (and before him the poet Robert Burns) said, "*The best laid plans of mice and men often go awry.*" Ours did when the WSU Foundation notified us last spring that they expected the minimum funding for a scholarship Gift Use Agreement to increase from \$25,000 to \$50,000. However, they also offered to let us lock in the original \$25,000 minimum if we would commit to contributing the remaining \$10,400 over the next five years. Otherwise the minimum would automatically increase to \$50,000, placing our plans to build a WSU Scholarship Endowment further out of reach.

After some negotiation over Gift Use Agreement terms this summer, and with final CRC and CRMF Boards approval, we committed to the agreement with WSU Foundation, agreeing to pay the remaining \$10,400 in five annual increments beginning on/before 1 May 2022. There is no interest and there is no 'early payment' penalty.

But there's a 'hook' (seems like there's always a 'hook'). Our being able to make these five payments of \$2,080 depends solely on your generous donations and continued support of your CRMF and your Scholarship Fund. The five \$2,080 payments are in addition to the current annual scholarship commitments of \$1,575 to WSU-Vancouver and approximately \$500 to Clark College (most is paid from our Clark endowment).

Though we gladly accept Scholarship Fund and Support the Troops Fund donations year-round we also have special appeals over the course of the year, and a large one is quickly approaching.

Our PCS (Post-Covid Scholarship) appeal was to be held this fall in conjunction with our annual fall BBQ (18 Sept). We regret having to cancel the BBQ and replace it with a ZOOM call. You'll be hearing more about the appeal in a letter to all chapter members. We encourage you to open your hearts and your checkbooks in response to the PCS appeal to help us lock-in the new increased (and long term) commitment toward the Chapter's Scholarship program at WSU-V.

These are good reasons to consider donating directly from your IRA account and simultaneously avoiding income tax on the amount withdrawn (**Dave** can provide more information or ask your IRA Custodian about making a "Qualified Charitable Distribution (QCD)"). [Note: Two of our members recently took advantage of QCDs to make generous donations to CRMF, and to avoid paying tax on their IRA withdrawals - a win-win for them and for us!]

Now for the other Foundation news. First, our funds continue to be bolstered by the Fred Meyer and Amazon Smile donations. While the amounts may seem insignificant, they are not. If you're not already a part of both please sign up and help increase their significance—if you need assistance signing up please contact **Dave Casteel**.

Second, since the last newsletter, the Boards approved making the following contributions, some of which are completed and some underway – all are from the Support the Troops Fund:

- \$1,015 Amazon Gift Card to the Fisher House
- \$500 in Gift Cards to the VA Transplant Lodge
- \$500 check to the Clark County Veterans Assistance Center (CCVAC)

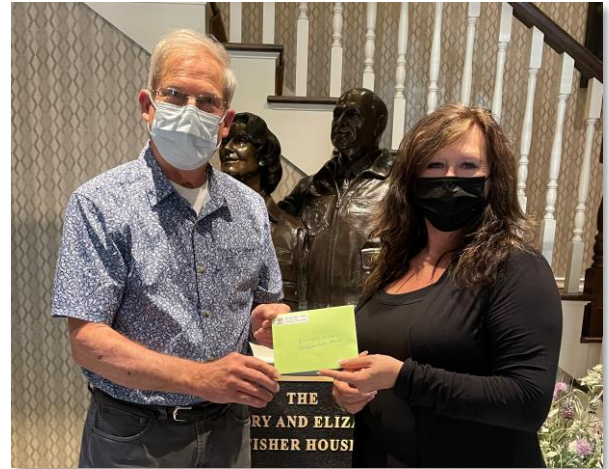
We still have funds budgeted for additional Veterans Support and will continue to evaluate options through the rest of the year.

We also temporarily delayed making our planned contributions to the AFJROTC Programs at Prairie and Battle Ground High Schools until after the beginning of the school year. We had a problem when one program experienced a lengthy delay between receipt and deposit of our check. This was caused by difficulties with handoffs and depositing into the correct accounts and exacerbated by COVID-19. We'll be working with the two programs to make sure these delays don't occur again this fall, to ensure the funds become quickly available to their programs.

Last, thank you again for your generous support of CRMF, the Funds we administer, and the organizations we support with our contributions. We are making real impacts in our community and in particular with the veterans and their families who live in our community. Every dollar donated goes to those programs.

COVID-19 Vaccines At The VA

All Veterans, their spouses and caregivers, and CHAMPVA recipients can now get a COVID-19 vaccine at VA.

All Veterans are now eligible for a COVID-19 vaccine at VA.

This includes anyone who served in the U.S. military, including the U.S. National Guard, Reserves, or Coast Guard.

This also includes anyone who served in any of these roles:

- Commissioned officer of the Regular or Reserve Corp of the Public Health Service, **or**
- Commissioned officer of the National Oceanic and Atmospheric Administration (or Coast and Geodetic Survey), **or**
- Cadet at the U.S. Military, Air Force, or Coast Guard Academy, **or**
- Midshipman at the United States Naval Academy

This also includes Veterans who live or travel outside of the U.S. and are eligible for the [VA Foreign Medical Program](#).

How to get a COVID-19 vaccine at VA

We encourage you to get your vaccine as soon as you can. It's the best way to protect yourself, your family, and your community against COVID-19. This is especially important as new forms (or "variants") of the coronavirus spread more quickly in the U.S.

- **Go to the facility's vaccine clinic during walk-in hours.** Be sure to check the walk-in hours before you go. When you arrive, you may need to wait for the staff to prepare your vaccine.
- **Or call the facility to schedule an appointment.** Our staff will help you find a time that's convenient for you.

Here's what to know before you arrive:

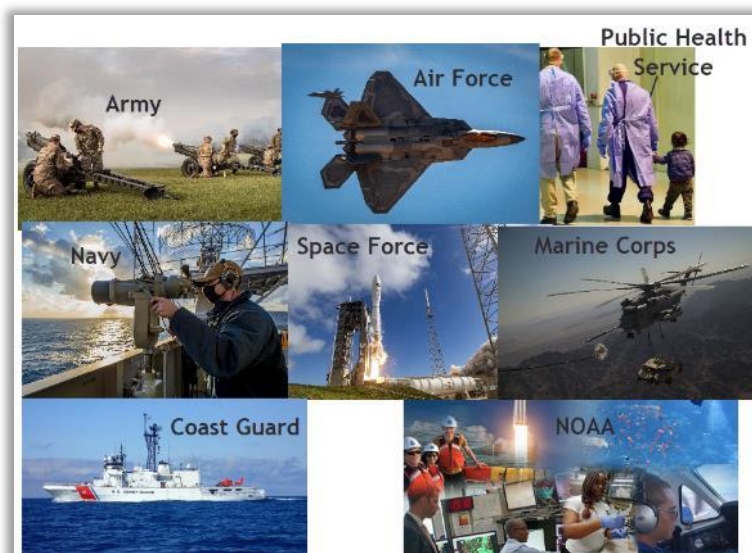
- **If you don't receive care at VA**, we encourage you to pre-register online at least 1 hour before you go to a walk-in clinic. This will save you time when you arrive.
Sign up to get a COVID-19 vaccine at VA
- **If you got your first vaccine dose outside of VA**, you can still get your second dose at VA.
- Everyone who enters a VA facility must wear a mask and complete our COVID-19 symptom screening.

Federal Legislative Update:

This newsletter comes at a pivotal time in the history of modern U.S. national security policy. Relationships with China, Russia, Iran and our allies combined with recent dramatic events in Afghanistan would make it easy for the MOAA Nation to be distracted from our advocacy mission. Add the pandemic crisis along with critical domestic issues like immigration make it difficult to stay focused on our job. Please resist that impulse by doubling down on your advocacy efforts.

Advocacy is something we can do to support the veterans who recently served in Afghanistan as well as the Gold Star families who lost loved ones. We all must remind ourselves of the potential impact of Afghanistan events on the lives of veterans who served in that region.

As I write this, stories about Afghan veterans in crisis are popping up all around the Nation. I implore you to remain watchful for any veterans needing help in our Clark County AOR. Members of veteran organizations in the county have energized our significant reach asking community leaders to be on the lookout for veterans needing help. Health officials are seeing an uptick in help requests. The VA staff has published a list of supportive resources for troubled veterans or their families. Do not forget to take Gold Star parents and families into your cross check. The most recent MOAA Newsletter contains good specifics on the subject of veteran support.

World and national events are smothering Federal legislative activities involving our servicemembers, veterans and their families. Debate over infrastructure and proposed FY22 budgets are making for a cloudy crystal ball regarding the defense portion of the budget.

In sum, with the roughly \$1 trillion infrastructure bill enjoying bipartisan support, attention shifted for a legislative minute to the \$3.5 trillion proposed Administration budget. Most defense analysts label it as proposing “limited” increases for defense. With inflation factored in, it is roughly a “flat” budget. A budget lagging behind inflation is by any computation, a budget cut. There is some good news

in that crystal ball. On Sept 1, the House Armed Services Committee dedicated 16 hours to marking up their version of the FY22 NDAA. They reviewed a record 780 proposed amendments. One amendment which passed increased the DOD topline by about \$25B. And, at around 2:30am on Sept 2, the committee approved the entire bill with an overwhelming bi-partisan vote of 57-2. Most political followers predict that defense could win the additional budget as part of a compromise solution involving the entire budget.

So where do MOAA’s top advocacy issues stand? Fortunately, our MOAA government relations team has saved us from a search effort by providing great summaries in their August 12 and 18 newsletters. The MOAA Newsletter contains a treasure trove of detailed information regarding details and the status of current legislative issues affecting our military family.

Here are a few of the hot button issues from this year’s Advocacy in Action activities:

- Toxic exposure reform is a huge goal of MOAA’s. It is the Agent Orange of the Central Asia conflict. There are two proposed Bills in both the House and the Senate. All are well co-sponsored. 10,000 messages from MOAA members are overwhelmingly given the credit for success to date.
- The same is true to a lesser extent for Bills proposing to help fix a serious food insecurity situation for thousands of junior military members and their families.
- Additionally, Parity for TRICARE Young Adults is doing reasonably well in the House but lagging other legislation in the Senate.

Given our current day to day stressful living environment, it would be a good time to also support the proposed Stop Copay Overpay Act. The bill would cap TRICARE mental health copays at the level paid for a primary care visit. Another proposal gaining support is a bill to increase the parity of incentive pay between active duty and reserve component members. Given the increased reliance on the Guard and the Reserve, it would appear to be common sense to offer similar benefits.

Now a word of caution. Kinda a good news, bad news report. Currently, MOAA says the annual inflation-based COLA computations point to an increase of as much as 6% for 2022. That's positive for retirement and social security adjustments. Good news. Bad news? Congress could arbitrarily cut that figure to much less and still claim they delivered the biggest retiree raise in ten years. Clearly, it would be an erosion of retiree earned benefits. We have seen this "play" before. Another great reason to keep your foot on the advocacy accelerator.
